## THE PROJECT

Since 1984, the Traditional Arts Apprenticeship Program (TAAP) has worked with some of the state's finest mentor/master folk artists to keep Missouri's artistic heritage alive and well. The **Traditional Arts Apprenticeship Program** funds teams of artistically excellent mentoring master artists and apprentices who are committed to sustaining their artistic traditions and cultural heritage. Teams develop work plans for the upcoming project year, meeting regularly to achieve their project goals. Priority is given to teams who share the same cultural community. Priority may also be given to living traditional arts with few practitioners left in the local community. Missouri Folk Arts staff continue to seek new TAAP applicants each year to better represent the spectrum of cultural communities across the state.

Missouri's **Traditional Apprenticeship Program** (TAAP), funded by the National Endowment for the Arts since inception, is coordinated by the Missouri Folk Arts Program with support from the Missouri Arts Council, a division of the Office of the Lieutenant Governor, and the Museum of Art and Archaeology at the University of Missouri.

## KEY DEFINITIONS AND APPLICATION INSTRUCTIONS

Please read carefully before filling out the application.

### I. KEY DEFINITIONS

**Traditional arts:** Rooted in and reflective of the cultural life of a community, folk and traditional arts are constantly evolving, shaped by values and standards of excellence passed from generation to generation, most often within family and community, through demonstration, conversation, and practice. Genres in folk and traditional arts include but are not limited to music, dance, crafts, foodways, dress/adornment, occupation, ceremony, and oral expression, including stories, poetry, and language. [*per the National Endowment for the Arts*]

**Cultural community:** A group sharing a wide range of commonalities, including ethnic heritage, cultural mores, language, religion, occupation, and/or geographic regions. Such groups share customs, heritage, and artistic expressions, which include the traditional arts.

**Mentor, or master, artist:** A traditional artist who is regarded by their cultural community and peers as a highly skilled and deeply knowledgeable practitioner and teacher of that group's traditional arts.

**Apprentice:** A talented traditional artist who possesses intermediate experience in the tradition (or a related art form), a strong desire to advance knowledge and skills in the art form, and a commitment to its continuity.

### II. APPLICATION INSTRUCTIONS

1. The mentor and apprentice must complete the application forms below. SECTION B is for mentor; SECTION C is for apprentice; and SECTION D is for both. Design the work plan to occur between January 1 and May 15, 2026.
2. Both mentor and apprentice must submit work samples with their application, or it is incomplete. Contact the Folk Arts Specialist to coordinate delivery via online storage, email, or postal service.

**Please note the requirements for work samples.**

- **Visual Art/Crafts/Foodways** teams should provide 5–8 digital images (JPEG, PNG) by each artist with short descriptions, including title and date. Include images that show close details.
- **Music/Storytelling/Verbal Traditions/Dance** teams should provide up to 5 minutes each of audio/video recording (in common formats like mp3, wav, mp4, mov, or mpeg4). Links to videos from YouTube or Vimeo are acceptable. Team should provide recording descriptions and time cues with application.

### III. APPLICATION ASSISTANCE

Applicants should contact Folk Arts Specialist Deb Bailey to discuss their proposals, work samples, and questions. She is available through November 5, 2025, to advise teams and to help coordinate delivery of materials through the November 19, 2025, due date. ### IV. ELIGIBILITY

- A mentor may teach more than one apprentice.
- Mentors who have participated for two consecutive cycles should pause one year before re-applying.
- The mentor artist must be a citizen or legal resident of the U.S.
- The apprentice must be a legal resident of Missouri.
- Apprentices under the age of 18 require guardian permission to participate.
- Awarded mentors and apprentices will be paid as suppliers of the University of Missouri and must meet full terms and conditions to receive artistic fees.

### V. REVIEW CRITERIA

- The art to be learned must be a traditional art as defined above.
- The mentor must demonstrate artistic excellence, cultural knowledge, and teaching ability.
- The apprentice must demonstrate intermediate experience and commitment.
- The work plan must be appropriate to the project, the traditional art form, and the team's goals.
- Priority is given to mentors and apprentices who share cultural communities.
- Priority is given to living traditional art forms with fewer practitioners.

### VI. REVIEW PANEL AND NOTIFICATION

A rotating independent panel of traditional arts specialists convenes to review applications and choose apprenticeship teams. The Folk Arts Specialist will notify mentors of the panel's decision in late December 2025.
